

Any portion of this guarantee or contract can not be copied duplicated or used for any reason.

Companion pet puppy shall be understood to mean that the puppy is considered solely as a companion pet and not a breeding prospect. BUYER understands that the sale of this puppy is PET only. Should it be found that the PUPPY has had offspring this contract will be considered breached and will render this contract and its contents null and void. Also a \$5,000 fine will be imposed on the BUYER through the United States Civil Court Judicial System.

Health Guarantee:

1. BREEDER guarantees the above-described puppy has received the appropriate shots and worming schedule for the PUPPY'S age. Health and immunization records will be included in the puppy's informational packet.
2. BREEDER guarantees your PUPPY for 7 days from the date of purchase against parvovirus, distemper, corona virus, hepatitis, and respiratory disease caused by adenovirus type 2 and parainfluenza.
 1. In the event the PUPPY dies from one of these diseases during that time, BREEDER will refund the full purchase price, or next available puppy of equal value.
 2. BUYER must notify BREEDER with a statement from BUYER'S veterinarian within 7 days confirming cause of death. The BREEDER will then have the information verified by their veterinarian
3. BUYER must take PUPPY to their veterinarian within three business days from the date of receipt for a health check and to set up a schedule for further immunizations.
 1. If this isn't done 7 day guarantee noted in item 2 is deemed null and void.
4. BREEDER guarantees your puppy against hereditary disorders that are detrimental to the PUPPY'S health, for two- years from the PUPPY'S date of birth.
 1. In the event this occurs, we will replace the PUPPY with the first available puppy of equal value.
 2. BUYER must notify BREEDER with a statement from BUYER'S veterinarian within 7 days of the problem being diagnosed. The BREEDER will then have the information verified by their veterinarian.
 3. Please note dental and allergy issues are not life inhibiting issues and therefore are not covered under the one year health guarantee.
5. BREEDER doesn't guarantee against intestinal or external parasites, ear infections, ear mites or other minor issues that are easily treated or relatively inexpensive.
 1. BREEDER does maintain a rigid treatment for treating intestinal and external parasites while PUPPY is in their care.
6. BREEDER doesn't guarantee against any cosmetic defects such as scar tissue left from a closed umbilical hernia, dew claws that grow back, undescended testicles, or small hernias that can be repaired when the puppy is neutered or spayed are of no danger to the puppy are also not covered.
7. BREEDER doesn't assume any liability for injury or medical cost after delivery, or pick up of puppy.
8. Guarantee valid only to original purchaser.

Care of PUPPY:

1. BUYER agrees to have annual veterinary checkups, including heartworm check, keep all immunizations current according to AVMA guidelines.
 1. This includes properly administering heartworm preventative as well as flea and tick preventative.
2. BUYER agrees to provide adequate housing for PUPPY according to state law.
3. BUYER agrees to keep PUPPY safe with a fenced yard or walking the dog in a leash, not tied to a chain or rope.
4. BUYER assumes the responsibility to carry on with the appropriate diet, exercise, feeding and grooming schedules.

Re-homing of PUPPY:

BUYER agrees that if for any reason, at any time the BUYER cannot continue to care for the PUPPY, or the PUPPY is not working out with the BUYER or BUYER'S family, including any animal family members, the BUYER is required to notify BREEDER immediately. Upon this occurrence the following steps will be taken...

1. BREEDER will try and resolve issues.
2. If a solution cannot be reached the BUYER is required to return the PUPPY to the BREEDER or allow the BREEDER to oversee the rehoming process.
 1. The BREEDER will rehome the PUPPY and the BUYER will receive the full price of the rehoming of the PUPPY agreed upon between the BREEDER and BUYER, not to exceed the original purchase price.
 2. Once the PUPPY is rehomed, the agreed fees will be sent to the BUYER minus a \$250.00 handling/deposit fee.
3. If the PUPPY lives outside of a reasonable area from the BREEDER then the BREEDER will assist in rehoming the PUPPY from the BUYER'S location by placing him/her back on the BREEDERS website or social media.
 1. The BUYER will receive full payment on the price agreed upon, minus a \$250.00 handling/deposit fee.
 2. The BUYER is responsible for all delivery charges and will not receive a refund on any delivery charges.
4. If the rehoming of your PUPPY becomes necessary and the BUYER does not contact the BREEDER, there will be a \$5,000.00 fine imposed through the United States Civil Court Judicial System.

Other:

1. Only guarantees stated in this written guarantee are in effect from the date of purchase.
2. BREEDER makes no other guarantees.
3. This contract is void if...
 1. BUYER does not have the PUPPY vaccinated according to the schedule established by a licensed veterinarian.
 2. BUYER fails to have a health check by a qualified veterinarian within 3 business days of date of receipt.
 3. BUYER does not provide for medical treatment as needed
 4. BUYER physically abuses the dog in any way.
4. BREEDER is not responsible for injury, illness or death due to accidents or neglect.
